

Park visitors are welcome to...

- enjoy the park during the operating hours of 7:00 am to 10:00 pm, except for approved special events.
- enjoy the fountains and gardens without entering the garden beds or fountains, pruning or removing plants, or picking flowers.
- deposit garbage in the park trash receptacles but removing items from the trash receptacles or littering is prohibited.
- enjoy the spray grounds or fountains without the use of bubbles, soaps, food or any other substances that may negatively impact the
 park, public, health, or general public safety.
- enjoy the park fountains but entering the fountains or letting your pet enter the fountains is prohibited.
- play in our free activity areas, but organized programs are not allowed without advanced park approval.
- bring children to enjoy the park but children under the age of 12 must be accompanied and supervised by an adult at all times.
- enjoy the Lincoln Financial Children's Garden, but only when accompanied by a child.
- allow children under the age of 12 to enjoy the Spin-A-Round, but only when accompanied by an adult.
- walk your pet on a leash if you clean up after it.
- use the Dog Park if you have three dogs or less and clean up after all pets.
- enjoy the Seasonal Plaza fountain or Children's Garden, but animals are prohibited in these areas with the exception of service animals.
- ride your non-motorized bikes, skateboards, or scooters on paved surfaces if you practice safe riding at all times and dismount when approaching crowded areas.

Park guidelines expressly prohibit...

- alcoholic beverages, except those purchased at LeBauer Park kiosks. LeBauer Park kiosk beer and wine may not be taken to Center City Park.
- the possession, distribution, sale, solicitation, or consumption of marijuana or any controlled substances in the parks.
- smoking or vaping, except in the designated smoking area in LeBauer Park.
- the defacement or damage of park property or material.
- firearms, except as permitted under N.C.G.S. 14-415.11.
- disorderly conduct, as identified in <u>N.C.G.S.</u> 14-288.4.
- storing or leaving any personal belongings in the park.
- climbing on sculptures, trees, or fences.
- large personal belongings including: suitcases, large storage containers, shopping carts, or other such items.
- erecting structures of any kind.
- the use of hammocks or camping gear (tents, lanterns, etc.) in the parks.
- panhandling.
- charitable distribution activities.
- commercial activity, except with approved permit.
- sitting or lying down in park entrances, exits, or pathways.
- blocking or impeding the park entrances, exits, or pathways.
- camping in the parks. Camping is defined as "any place where bedding, sleeping bags, or other material used for bedding purposes, or any stove or fire is placed for the purpose of maintaining a temporary place to live."
- flyers without GDPI approval or the posting of flyers in undesignated areas. Flyers without approval or that are posted in undesignated areas are subject to a cleanup fee.
- the blocking of sidewalks in accordance with Greensboro City Ordinances.
- the riding of animals and/or the molestation of or causing injury to an animal.
- feeding wildlife.
- sound amplifying devices that can be heard at a distance of more than 10 feet, except for pre-approved events.
- motorized recreational vehicles, including scooters, skateboards and bikes.
- aerial drones, unless approved by GDPI staff and maneuvered by licensed pilots.
- fires, barbecuing, outdoor cooking, or any open flame.
- remote control cars, boats, helicopters, planes, etc.
- events, unless pre-approved by GDPI staff. Any activity including equipment setup, marketing/sales or elevated sound/performance is considered an event.

Failure to comply with these rules and regulations may result in a warning, citation, banning, or arrest. Park Rules and Regulations are subject to change without notice.
